Information Sharing – for enhanced court technology

- Silently communicate with officers about events happening live within the court, by using a real-time crisis communication messaging tool.
- Immediately identify persons who may be a threat to the court, through CJIS queries and advanced people and vehicle searches from information added by officer and court subscribers.
- Access civil process issuances and violations along with advanced people searches.
- Create and automatically receive Attempt to Locate and BOLO warning alerts from a database shared among courts and law enforcement.
- Verify deferred disposition compliance or violation with CJIS query returns and the statewide COPsync citation history database.

Safety and Security – for enhanced court security

- Turn every Microsoft Windows computer in the court into a panic button alert threat notification device.
- Outfit your employees with a mobile installed threat alert panic button. (Mobile Web App.)
- Broadcast threat notifications directly to the closest officers in their patrol cars.
