

The Onit Contract Administration App is an affordable and easy-to-use App that lets you manage all of your contracts in one secure place. A contract administrator simply logs in to the App and sees a Dashboard View of all of their active and inactive contracts. The contract administrator has the ability to drill into an existing contract or add a new contract.

Adding a new contract can be created with one click and the contract administrator can completely customize the fields they wish to see. Once the contract has been added, they can set reminders such as contract expiration or renewal dates and add relevant notes and documents.
